## DESIGN AND ENGINEERING

### Internship Program

DCA launched an internship program in summer of 2020, 2022 and again in 2023. The program provides college-level students hands-on learning experience about the planning process and design aspects of public infrastructure construction. The interns gain valuable experience including the opportunity to apply concepts in communications, engineering and environmental review.

Four interns participated in the 2025 DCA Summer Intern Program. Two interns supported the environmental engineering team, and two supported the engineering design team. In addition to gaining practical experience through work assignments, the interns participated in career talks, tours, and other activities to build their understanding of California's water supply system. The interns were paid and worked in a hybrid model. They will continue their education at their respective universities, including UC Davis and Sacramento State. ### Delta Library Resources

Delta area public libraries are a continuous resource for the Delta community at large.
